Re: Citizen Advisory Committee recommendations for 2014 CDBG funding

On February 28, 2014, the Citizen Advisory Committee (CDcac) presented recommendations to the City Council based upon an anticipated \$325,000 in 2014 funding with the caveat that if this amount was changed, the recommendations would be adjusted accordingly. HUD has notified us that our 2014 funding is \$343,087. Consistent with the CDcac recommendations, the adjusted funding follows:
