Brief Description of Proposed Action: The Geysers Road Safe Routes to School project will provide missing critical sidewalk connections along the south side of Geysers Road (County Route 43) initiating at Tiffany Place and terminating at Casino Drive. The project will provide a signalized pedestrian crossing near the east Geysers Road Elementary School driveway and a sidewalk linking the crossing location to the existing school sidewalk network. The Geysers Road Trail project consists of providing a separate side path along the north side of Geysers Road from the Town of Milton/City of Saratoga Springs line to the intersection with NYS Route 50. The Geysers Road/Route 50 Intersection Project includes widening on the Geysers Road approach to accommodate a left-turn lane. A side path will be provided on the north side of Geysers Road. New pedestrian crossings will be provided on Geysers Road and NYS Route 50.
