MEMORANDUM OF UNDERSTANDING

Between the

Schenectady Fire Department

And the

City of Saratoga Springs Fire Department

PURPOSE:

For the 2014 Application Period the Schenectady Fire Department will be submitting a grant proposal to the Assistance to Firefighters Grant Program for the purchase of equipment which will be utilized by fourteen (14) Fire and EMS agencies within the Regional Emergency Medical Organization. This equipment consists of updated and current model monitor / defibrillators.

To meet the requirements of the Assistance to Firefighters Grant program a Memorandum of Understanding must be established to identify those jurisdictions responsible for matching funds associated with the emergency medical services equipment identified in the grant.
