I am pleased to provide this supplement to the May 28, 2014 proposal for additional construction oversight, grant assistance and consultation related to the Weibel Avenue Landfill Gas Blower System and Flare.

Construction Oversight – Daily on site construction oversight for the construction, installation and testing of the subject collection system modifications and new blower station and flaring system. The electrical credit represents a credit to the City of \$6,000 for electrical design that was included in the 5/28/14 proposal estimate but was subsequently contracted out separately to Barton & Loguidice and not performed by Wehran Energy Corp.



**Agreement Addendum Two Between City of Saratoga Springs, NY
and Wehran Energy Corporation
Weibel Avenue Landfill Gas Project**

This Addendum Two, between Wehran Energy Corporation with offices at 730 Route 202, Mahwah, NY 07430 ("Consultant") and the City of Saratoga Springs ("City"), 474 Broadway, Saratoga Springs, NY 12866 entered into between the above referenced parties on the effective date of September 15, 2015 is hereby added to the original Agreement dated January 15, 2013 and Addendum 1 dated June 3, 2014. The original Agreement had a total Contract sum of \$3,500.00 and Addendum One had an additional contract sum of \$60,000.00, bringing the total authorized Contract sum and authorized amount prior to this Addendum Number Two to \$63,500.00

Additional Services Provided: Consultant shall provide additional professional services as described in the engineering proposal titled "Weibel Avenue Landfill Gas Blower System and Flare Supplement Agreement for Construction Oversight, Grant Assistance, and Consultation" dated September 11, 2015. Invoicing for the additional services shall be on an hourly fee basis not to exceed Twenty-six thousand One-hundred and Sixty-five Dollars (\$ 26,165.00), a copy of which is hereto attached. The Consultant represents that the company providing this service is qualified to perform the type and scope of work to be done.

Accordingly, this Agreement Addendum Two brings the Total Authorized Contract Amount to: Eight-nine thousand Six-hundred Sixty-five dollars (\$89,665).

The City's Risk and Safety Agreement shall become a part of the original agreement and this Agreement Addendum Two. All other terms and conditions of the original Agreement remain the same.

The parties, having agreed to the terms and the recitals set forth herein, and in relying thereon, herein sign this Agreement.
