CALL TO ORDER

Mayor Yepsen called the meeting to order at 9:36 a.m.

PUBLIC HEARING

Zoning Text Amendment for Saratoga National Golf Course

Deputy Maire Masterson stated this public hearing was set at the last Council meeting per the applicant's request.

Commissioner Madigan asked what the process will be as a step has been missed.

Mayor Yepsen advised lead agency still needs to be determined before SEQRA can be done.

Brad Birge of the Planning Department stated he would not classify this as a missed step but it is a crucial step of the process. This item was presented by the applicant for a zoning amendment that would apply to all of the RR district. The Council needs to determine if they wish to seek lead agency or defer it to the Planning Board.

Commissioner Madigan stated she clearly heard Mark Schachner say at the Planning Board meeting that this should not be looked at with a specific project in mind. She is concerned that Brad is looking at this as project specific not just a zoning amendment and that the public doesn't know where the Council stands on this. Is it appropriate to have a public hearing at this point? It doesn't appear this is playing out appropriately for the public.

Brad advised this is a proposed zoning amendment to the City Council. The Council is under no obligation to move forward with this if they don't wish to.

Commissioner Madigan doesn't want the Council to be seen as doing spot zoning because they know a project may come after the zoning change.

Mayor Yepsen stated they need to determine if they are looking at the zoning amendment only or if they are looking at both at the same time.

Commissioner Madigan is still questioning if the determination of lead agency needs to occur.

Commissioner Mathiesen stated the lead agency should be the City Council as they are the ones who will make the determination regarding a zoning text amendment.

Tony Izzo, assistant city attorney, stated the definition he read creates a term of golf resort and defines specific criteria that has to be in place for a golf resort.
