CALL TO ORDER

Mayor Yepsen called the meeting to order at 9:35 a.m.

PUBLIC HEARING

2016 Proposed Comprehensive Budget

Mayor Yepsen advised the Council received a more comprehensive contract last week. Mr. Honeywell will be here tomorrow and available to answer any questions by e-mail and phone.

Commissioner Madigan advised she has a few questions regarding things that didn't transfer well from the MOA to the contract. She hasn't completed the cost-outs but is prepared to bring forward how we are going to bring forward the cost of the contract.

Discussion and Vote: Authorization for Mayor to Sign Agreement with Alta Planning and Design for Excelsior Cross Section Plan

Kate Maynard of the Planning Department advised this is a joint venture with the Department of Public Safety for the Excelsior Avenue corridor. This relates to travel lanes, curbing, utility poles, etc. – the physical details. The amount is \$15,000 being covered by public donations.

Discussion and Vote: Authorization for Mayor to Sign Agreement with Saratoga Springs City Center for 50th Anniversary of Vietnam Commemoration Event

Mayor Yepsen advised the event is being held on November 21st.

<u>Discussion and Vote: Resolution Requiring Contractors to Have Approved Apprenticeship Programs for</u> <u>City Projects</u>

Mayor Yepsen advised this was voted on once. They looked at it again with labor unions and are trying to revisit as the current threshold is too high. This will now apply to contractors doing business in excess of \$250,000 or subcontractors doing business in excess of \$25,000.

Commissioner Madigan sent an e-mail regarding the subcontractor; why they went from \$100,000 to \$25,000.

Vince DeLeonardis stated they did not eliminate want to lower the threshold too low where it would prohibit subcontractors from being able to provide work on a project.

Commissioner Scirocco stated he would be ok with having the contractor amount being \$225,000.

Commissioner Mathiesen confirmed infrastructure is no longer excluded.

Tim Wales, city engineer, stated his original discussions about the infrastructure being excluded was due to not getting a lot of bids on our projects and this would further eliminate some. Contractors with higher overhead will be the only ones able to bid.

Mayor Yepsen confirmed they are going to move forward with lowering the contractor threshold to \$225,000.

Discussion: High Rock Lot RFP Review Update

Mayor Yepsen advised they are looking for the bidders to meet with the Council on November 9th or 10th.

Commissioner Madigan inquired if they should be moving forward with the proposals since there is pending litigation regarding the solar ordinance.
