## **CITY CENTER LEASE AGREEMENT**

### **AMENDMENT**

**THIS AMENDMENT**, made on March \_\_\_, 2018 by and between the **CITY OF SARATOGA SPRINGS, NEW YORK**, a municipal corporation with offices at 474 Broadway, Saratoga Springs, New York 12866 (hereinafter referred to as "**CITY**") and the **SARATOGA SPRINGS CITY CENTER AUTHORITY**, an entity formed under the Public Authorities Law of the State of New York (hereinafter referred to as "**AUTHORITY**").

**WHEREAS**, the CITY and the AUTHORITY entered into a Lease Agreement (herein after referred to as "**LEASE**") on December 21, 2005, a true and complete copy of which is annexed hereto and marked as **EXHIBIT "A"**; and

**WHEREAS**, under the terms contained within the LEASE, the City has leased to the AUTHORITY certain premises commonly known as the "City Center"; and

**WHEREAS**, paragraph numbered and designated "**13. Amendments**" of the LEASE provided that same may be amended upon the concurring written consent of the parties; and

**WHEREAS**, pursuant to the aforesaid paragraph, the parties herein wish to amend the LEASE relative only to paragraph numbered and designated "**3. USE**"; and

**NOW THEREFORE**, paragraph numbered and designated "**3. USE**" of the LEASE is hereby amended and shall now read as follows:

**3. USE**

The AUTHORITY shall, during the term of this lease, use the Center as a convention and trade show facility and for related purposes only, except that the Center shall not be used for the sale or display, or to promote the sale or display, of firearms, or ammunition as defined in New York State Penal Law §265.00, other than antique firearms as defined in that section.

The AUTHORITY is presently bound under a fully signed function contract dated February 8, 2018 with NEACA, Inc., which has rented the City Center for an "Arms Fair" scheduled to occur Friday, May 25 through Sunday, May 27, 2018. The rental charges payable under said contract total \$7,500, of which \$3,750 has been paid.

With respect to said "Arms Fair", and in light of the fully signed function contract, the CITY and the AUTHORITY agree to allow said "Arms Fair" to occur as scheduled in order to avoid involving the parties in protracted litigation and expense.


All other terms and conditions of the original December 21, 2005 LEASE between the Parties (Exhibit "A") shall continue and remain the same as if fully set forth herein.


